Account name	Cash ISA Saver Account
What is the interest rate?	0.65% Tax-free/AER The interest is paid annually and will be credited to your account after close of business on 1 January.
Can Progressive change the interest rate?	Yes, the interest rate is variable. We can increase or decrease the interest rate as described in our Savings General Terms and Conditions. If we are decreasing the interest rate we will notify you at least 14 days before the change takes effect.
What would the estimated balance be after 12 months based on a £1,000 deposit?	£1,006.50 This is an example based on an initial deposit of £1,000 made on account opening and assumes no further deposits or withdrawals are made throughout the year and that the interest rate does not vary during the 12 month period.
How do I open and manage my account?	The account is available to existing Members and new customers resident in Northern Ireland only who are aged 16 years and over. There is a minimum lodgement of £1,000 required to open this account. You can save up to a maximum of the annual ISA allowance (£20,000 for the current tax year). The account can be opened and operated at any of the Society's branches, agencies or by post.
Can I withdraw money?	Yes, this is an instant access account, withdrawals are allowed. You can make 2 withdrawals per tax year (6 April - 5 April) without loss of interest. You can withdraw up to £500 in cash in a branch and £250 in cash in an agency, larger amounts must be withdrawn by cheque.
Additional information	AER stands for Annual Equivalent Rate and illustrates what the interest rate would be if interest was paid and compounded once each year. This will enable you to compare more easily the return you can expect from your savings over time. This is a tax free account which means the interest paid is exempt from income tax. The interest rate is correct as of 31 March 2022.

Account terms and conditions

- when you open an account you will be given a passbook to help you keep a record of your transactions and account balance.

Balance requirements

- there is a minimum lodgement of £1,000 required to open this account.

Lodgements

- you can save up to a maximum of the annual ISA allowance [£20,000 for the current tax year];
- you can only subscribe to one Cash ISA in the same tax year, although over 18s may invest in a Stocks and Shares ISA, an Innovative Finance ISA and a Lifetime ISA. At Progressive we only offer the Cash ISA.

Withdrawals

- you can make 2 withdrawals per tax year (6 April - 5 April) without loss of interest;
- if you make more than 2 withdrawals within the tax year the account will become an instant access Cash ISA at the interest rate applicable at that time. If we change your account to an instant access Cash ISA we will write to you and give you 30 days notice;
- you can withdraw up to £500 in cash in a branch and £250 in cash in an agency, larger amounts must be withdrawn by cheque;
- you can make a withdrawal and replace money from your Cash ISA Saver without counting towards your annual ISA allowance for that year, as long as the repayment is made in the same tax year as the withdrawal;
- when you make a withdrawal you must present your passbook and valid photographic identification.

Closure

- you can close your Cash ISA Saver at any time, however, you will lose the associated tax benefits unless you transfer your Cash ISA Saver to another ISA provider;
- when you close your account you must present your passbook and valid photographic identification.

Transfers

- the Society will not accept transfers in from other ISA providers;
- you may transfer your Progressive Cash ISA to another ISA provider. When we receive your transfer instructions from your new ISA provider, we will send the funds and accompanying information to the new ISA provider within 5 banking days of the day of receipt;
- for further information please contact your local branch.

Interest

- interest is paid annually and will be credited to your account after close of business on 1 January and can be transferred to another Progressive account or to your nominated bank account*;
- if you opt to have your interest paid to another Progressive account, you will receive the interest on the next banking day after the interest payment date;
- if you opt to have your interest credited to your nominated bank account* you will receive this electronically, 2 banking days after the interest payment date;
- by banking day we mean Monday to Friday excluding bank holidays;
- interest is paid on closure of the account;
- if the account balance falls below £1,000 the Society's Ordinary Share rate applicable at that time will apply.

*Nominated bank account

The nominated bank account must be in the name of the account holder i.e. the individual named on the account.

HM Revenue & Customs ISA terms and conditions

Issued by HM Revenue & Customs

- the ISA investments will be, and must remain in, the beneficial ownership of the investor and must not be used as security for a loan;
- the ISA manager will satisfy himself that any person to whom he delegates any of his functions or responsibilities under the terms agreed with the investor is competent to carry out those functions and responsibilities;
- the ISA manager must notify the investor if, by reason of any failure to satisfy the provisions of the ISA regulations, an ISA has, or will, become void.
- on the instructions of the investor and within the time stipulated by the investor, an ISA, or part of an ISA, shall be transferred to another ISA manager in accordance with the ISA regulations relating to transfers;
- on the instructions of the investor and within the time stipulated by the investor, all or part of the investments held in the ISA and proceeds arising from those investments shall be transferred or paid to the investor.
